With regard to the FTA Colombia – South Korea, we include the information through which we fulfill the commitments assumed by Colombia, in accordance with Annex 14-A Section J: "THRESHOLD ADJUSTMENT FORMULA", point 5: "Each Party shall notify the other Party of the value of the thresholds in its national currency immediately after this Agreement enters into force, and the newly calculated value of the thresholds thereafter in a timely manner". Effective for the period January 1, 2026 – December 31, 2027
