### SCHEDULE OF CHILE'S COMMITMENTS TO SINGAPORE

  - (b) for government procurement of construction services: **SDR 5,000,000.**

# Section B: Entities at the Sub-central Level of Government

- 1. Chapter 14 (Government Procurement) applies to procurement by the Sub-Central Level of Government Entities listed in this Section where the value of the procurement is estimated, in accordance with Article 14.5 (Valuation), to equal or exceed the following relevant threshold:
  - (a) For government procurement of goods and services: **SDR 200,000.**
  - (b) For government procurement of construction services: **SDR 5,000,000**.
- 2. The monetary thresholds set out in paragraph 1 shall be adjusted in accordance with Section H of this Schedule.

# 1. All Municipalities

## **Section C: Other Entities Covered**

- 1. Chapter 14 (Government Procurement) applies to entities listed in this Section where the value of the procurement is estimated, in accordance with Article 14.5 (Valuation), to equal or exceed:
  - (a) For government procurement of goods and services: **SDR 400,000.**
  - (b) For government procurement of construction services: **SDR 5,000,000.**
- 2. The monetary thresholds set out in paragraph 1 shall be adjusted in accordance with Section H of this Schedule.
- 3. This Section covers only those entities specifically listed below.

## **Section D: Goods**

Chapter 14 (Government Procurement) applies to all goods procured by the entities listed in Sections A through C of this Schedule, unless otherwise specified in Chapter 14 (Government Procurement), including this Schedule.

# **Section E: Services**

Chapter 14 (Government Procurement) shall apply to all services procured by the entities listed in Sections A to C of this Schedule, except the following:

Financial Services: All classes

### **Section F: Construction Services**

- 1. Chapter 14 (Government Procurement) applies to all construction services procured by the entities listed in Sections A through C of this Schedule, unless otherwise specified in Chapter 14 (Government Procurement), including this Schedule.
- 2. Chapter 14 (Government Procurement) shall not apply to construction services intended for Easter Island (*Isla de Pascua*).

#### **Section G: General Notes**

Chapter 14 (Government Procurement) does not apply to procurements in respect of financial services.

## **Section H: Threshold Values**

- 1. The thresholds shall be adjusted in every even-numbered year with each adjustment taking effect on January 1, beginning on January 1 of the first even-numbered year after the date of entry into force of the Agreement.
- 2. Every two years, Chile shall calculate and publish the value of the thresholds under Chapter 14 (Government Procurement) expressed in Special Drawing Rights (SDR). These calculations shall be based on the average of the daily conversion rates of the Chile currency in terms of SDR, published by the International Monetary Fund in its monthly International Financial Statistics over the two-year period preceding October 1 or November 1 of the year before the adjusted thresholds are to take effect.

- 3. Chile shall notify the other Party of the current thresholds in its national currency immediately after the Agreement enters into force, and the adjusted thresholds in the Chile currency thereafter not later than one month before the thresholds take effect. Thresholds expressed in the respective national currency shall be fixed for a period of two years, i.e. calendar years.
- 4. Chile shall consult if a major change in the Chile currency relative to the SDR or to the national currency of the other Party were to create a significant problem with regard to the application of Chapter 14 (Government Procurement).
