### ANNEX 14-A

#### SCHEDULE OF MEXICO'S COMMITMENTS TO SINGAPORE

#### Section A: Entities at the Central Level of Government.

The specific coverage in relation to procurement by entities at the central level of government established between Mexico and Singapore in Section A of Annex 15-A (Schedule of Mexico) of the Comprehensive and Progressive Agreement for Trans-Pacific Partnership ("CPTPP") shall apply to procurement covered under Chapter 14 (Government Procurement) between Mexico and Singapore.

### Section B: Entities at the Sub-central Level of Government

The specific coverage in relation to procurement by entities at the sub-central level of government established between Mexico and Singapore in Section B of Annex 15-A (Schedule of Mexico) of the CPTPP shall apply to procurement covered under Chapter 14 (Government Procurement) between Mexico and Singapore.

### **Section C: Other Entities Covered**

The specific coverage in relation to procurement by other entities covered established between Mexico and Singapore in Section C of Annex 15-A (Schedule of Mexico) of the CPTPP shall apply to procurement covered under Chapter 14 (Government Procurement) between Mexico and Singapore.

# **Section D: Goods**

The specific coverage in relation to procurement of goods established between Mexico and Singapore in Section D of Annex 15-A (Schedule of Mexico) of the CPTPP shall apply to procurement covered under Chapter 14 (Government Procurement) between Mexico and Singapore.

## **Section E: Services**

The specific coverage in relation to procurement of services established between Mexico and Singapore in Section E of Annex 15-A (Schedule of Mexico) of the CPTPP shall apply to

procurement covered under Chapter 14 (Government Procurement) between Mexico and Singapore.

## **Section F: Construction Services**

The specific coverage in relation to procurement of construction services established between Mexico and Singapore in Section F of Annex 15-A (Schedule of Mexico) of the CPTPP shall apply to procurement covered under Chapter 14 (Government Procurement) between Mexico and Singapore.

#### **Section G: General Notes**

The general notes established between Mexico and Singapore in Section G of Annex 15-A (Schedule of Mexico) of the CPTPP shall apply to procurement covered under Chapter 14 (Government Procurement) between Mexico and Singapore.

### **Section H: Threshold Values**

The specific coverage established between Mexico and Singapore in Annex 15-A (Schedule of Mexico) of the CPTPP shall apply to procurement covered under Chapter 14 (Government Procurement) between Mexico and Singapore.
